# **ANNUAL PASS DISCOUNTED**

Dues are collected each calendar year and correspond to the lodge's annual recharter. Lodge members have two options for paying their dues. Arrowmen may pay their dues, then pay for each event they attend; or they may purchase an annual pass at a discounted rate. The annual pass covers the event registration cost of all local lodge events, plus an extra event patch for those who preregister and attend the event.

We recently reached the halfway point in our lodge's calendar, so the annual pass is now discounted by 50% (to preserve the savings for the remaining lodge events). # **ADVISER'S CORNER**

The previous edition of the Adviser's Corner was devoted to the OA Mission, which calls upon our youth leadership to fulfill the OA Purpose through positive leadership, under the guidance of selected capable adults. But what is the OA Purpose and how does it relate to the Arrowmen of Muscogee Lodge? Dr. E. Urner Goodman, our Order's cofounder, understood the importance of Scout spirit when he suggested "the Order of the Arrow is a thing of the spirit rather than of mechanics." In other words, it is not enough to simply follow the Scout Oath and the Scout Law in our actions; the intent behind our actions provides context and amplifies their meaning. When the spirit of Scouting pervades our actions, a Scout can be said to have succeeded in realizing the Order of the Arrow's first purpose.

You are each encouraged to take a moment to enjoy your successes, if only to balance out the time spent reflecting on any missed opportunities. Remember that many of the things in life that are worth doing are difficult and require both insight and repetition. But whatever you do, do it well, and may success attend your efforts.

# Lodge Rule Amendment 2024 Summer Super Fellowship

# Explanation

This amendment will help jumpstart the process of creating and vetting memorabilia while maintaining the requirement that the youth approve all non-lodge and section event items at a lodge business meeting. Lodge and section event patches will continue to be approved by the LEC, matching the current lodge rules. This allows the LEC to plan the year's program and approve designs consistent with the program design. It will also help ensure that all patches arrive on time for events, preventing what happened at the Spring Fellowship where the patches did not arrive in time for attendees to receive them and for the lodge to sell them in person.

Ultimately, the intent of this amendment is to protect the lodge brand and its long-term health, while enabling the lodge to more easily raise funds for its members. Also, the new process will simplify and shorten lodge business meetings and clarify ambiguities in the current PIM process.

# XIII. Lodge Insignia and Memorabilia

# Current Lodge Rule

A. Lodge insignia and memorabilia will be defined as any patch, flap, chenille, jacket patch, bullion, neckerchief, belt buckle, or similarly manufactured item containing any of the lodge name, number, totems, logo, brand, or other characteristic mark as determined by the Lodge Key-3 in consultation with the Lodge Vice Chief of Finance and their adviser.

B. The creation of any lodge insignia or memorabilia must be approved by a two-thirds (2/3) majority vote at a lodge business meeting. Excluded from this requirement are lodge event and conclave patches, which must be approved by a two-thirds (2/3) majority vote at a Lodge Executive Committee Meeting. If a member of the lodge should be elected to serve as a national youth officer, the Lodge Executive Board, by a two-thirds (2/3) majority vote, may select and approve the creation of lodge insignia or memorabilia commemorating and honoring the individual's election to the office.

C. The creation of any chapter insignia or memorabilia must be approved by a two-thirds (2/3) majority vote at a chapter meeting with at least one-tenth (1/10) or 6 chapter members present, whichever is greater.

# D. [Proposed to remain as-is.]

E. In all instances of proposed lodge or chapter insignia/memorabilia, the relevant decision making body, as described in Subsections XIII-B and C of these rules, must first authorize the Lodge Patches, Insignia, and Memorabilia Committee to review proposals and make recommendations to the originating body as described in this section.

# Proposed Amendment

A. Lodge insignia and memorabilia will be defined as any patch, flap, chenille, jacket patch, bullion, neckerchief, or similarly manufactured item containing any of the lodge name, number, totems, logo, brand, or other characteristic mark as determined by the Lodge Key-3 in consultation with the Lodge Vice Chief of Finance and their adviser.

B. The creation of any lodge insignia or memorabilia must be authorized by a two-thirds (2/3) majority vote at a Lodge Executive Committee Meeting. This action authorizes the Patches, Insignia, and Memorabilia Committee to solicit and consider designs, then make a recommendation to the Lodge Executive Committee. The Lodge Executive Committee will consider this recommendation and make a final recommendation to the lodge for approval, which will require a majority vote at a lodge business meeting. The Lodge Executive Committee may eliminate designs from consideration if more than three (3) should be proposed, but must recommend at least three (3) in such cases.



C. Excluded from requirement XIII-B are lodge event and conclave patches. The Patches, Insignia, and Memorabilia Committee will solicit and consider designs, then make a recommendation to the Lodge Executive Committee. The Lodge Executive Committee will consider this recommendation and select a design by a majority vote at a Lodge Executive Committee Meeting.

D. If a member of the lodge should be elected to serve as a national youth Order of the Arrow officer, the Lodge Executive Committee, by a two-thirds (2/3) majority vote, may authorize the Patches, Insignia, and Memorabilia Committee to solicit and consider designs to commemorate this achievement, then make a recommendation to the Lodge Executive Committee. Such items may then be approved by a majority vote at a Lodge Executive Committee Meeting.

E. The creation of any chapter insignia or memorabilia must first be authorized by a two-thirds (2/3) majority vote at a chapter meeting with at least one-tenth (1/10) or 6 youth chapter members present and voting, whichever is greater. This action authorizes the Patches, Insignia, and Memorabilia Committee to solicit and consider designs from members of the chapter, then make a recommendation to the chapter for approval, which will require a majority vote at a chapter business meeting with at least one-tenth (1/10) or 6 youth chapter members present and voting, whichever is greater. Before any chapter insignia or memorabilia may be produced, a sufficient quantity of pre-orders must first be secured as determined by the Lodge Key-3.

F. The Patches, Insignia, and Memorabilia Committee will be responsible for soliciting, reviewing, and enforcing standards for all lodge and chapter insignia and memorabilia designs. It will work with designers and other stakeholders to develop a recommendation to the relevant decision making body as prescribed in this Section. The final decision making body may only accept or reject designs; it may not modify them. In instances pursuant to Subsection XIII-B where the Lodge Executive Committee reviews the recommendations of the Patches, Insignia, and Memorabilia Committee, the Lodge Executive Committee is permitted to modify designs before a recommendation is made to the appropriate decision making body.

G. Should all designs be rejected at any point in the processes set forth in this Section, the matter is referred back to the Patches, Insignia, and Memorabilia Committee for additional consideration. Such consideration may include the solicitation of new designs, if authorized by a majority of the LEC. Any new designs will be referred to the Patches, Insignia, and Memorabilia Committee for its consideration and recommendations.

H. Following the approval of the relevant decision making body to create an item of insignia or memorabilia, the Lodge Key-3 will be responsible for any final design decisions but in keeping with the integrity of the approved design.
